# **National Office Report/DFO Report**

Sheila Andrews, will attend. The first Joint Committee (JC) meeting is March 25, 2021 at 1:30pm ET. English reported that the tax forums will be virtual again this year and TAP will have its own virtual room to be staffed by TAP members.

New members are encouraged to attend at least one JC meeting to see the flow of issues to the IRS. English welcomed William Vetter as a new member. #### **Outreach Report**

  Groff offered his assistance to any members who need outreach ideas.
  Groff said social media and some professional environments are good options. Snyder said during the recruiting process and Groff added during tax season are good times for outreach. Smith met with the District of Columbia (DC) Taxpayer Advocate for outreach opportunities. (Smith's IRS LTA is James Leith). Groff speaks to his LTA on a quarterly basis. English mentioned the LTAs are required to reach out to TAP members. You can reach out to them if they have not contacted you. All of this should be accounted for on the Activity Reports, per Ross. Ross will help with introducing Vetter with his LTA. (Activity Reports are due on day 25 of each month.)

# Approval of IRS Responses

- Issue 41749- Not adopted: Snyder remarked that IRS control contractors used to deliver the mail outside the US. Online options are expected by 2023, per Ross. Response sent back to subcommittee, new recommendation to be considered.
- Issue 42967- Not Adopted, returned to subcommittee for reconsideration.
- Issue 42996- Are overseas TPs allowed to use Free File? Snyder said some of the requirements cause difficulties for this to be used as it may be



more complicated. Awalt said <u>www.irs.gov</u> is the easiest way to use this for overseas taxpayers.
