- The work done by committees is to advocate on behalf of taxpayers
- Members were reminded to take advantage of opportunities to conduct outreach utilizing social media.

# **Screening Committee**

Andrea Price stated the Screening Committee met on March 31, 2021. She provided an update on seven items that were submitted by Taxpayers:

- Four Issues: #43840 Economic Impact Payment 1040 claim dependent box, #43844 Contacting the IRS, #44413 Credit for our owed taxes, #44527 Tried to contact the TAS. The Screening Committee decided to drop all four Issues after the Analyst contact taxpayers and refer them to TAS.
- Issue #44516 Taxpayer requests LITC information and #44402 Para cuando estara listo me impacto economico tene were both dropped as individual issues and the taxpayers submitted no contact information.
- Issue #47303 Problem with Phone Systems was associated with Issue #43501 Out of Scope Topics Telephone Assistors will not Answer to be worked

The Screening Committee motioned, and Pamela Memmer seconded to accept the Screening Report as submitted.

## **Subcommittee 1**

Price stated Subcommittee1 reviewed 2 Issues:

- Issue #43632 Reposition Telephone Prompts; Members discussed the IRS rejection response. Subcommittee 1 decided to draft a rebuttal. Donna Burris will conduct further research and prepare a rebuttal by April 20, 2021.
- Issue #43501 Out of Scope Topics Telephone Assistors will not answer
  Subcommittee 1 reviewed the Issue and was pleased that IRS has
  implemented their recommendation though TAP did not receive credit for
  it. Subcommittee 1 members will review associating Issue #47303 with
  Issue #43501 during their next meeting

# **Subcommittee 2**

Cynthia Pinkney stated Subcommittee 2 began work on two referrals:

- Issue #43395 Recommending IRS Update CP141L Notice to include the correct telephone number
- **Issue #48550** asks IRS to add a Public Service Announcement to Out-of-Scope list on the website.



• Issue #42231 IRS telephone numbers should be listed in the 1040 Instructions Subcommittee 2 is working on submitting a reconsideration to include the telephone number

Pamela Memmer provided the following Outreach activity:

## **Internal Communications Committee (ICC)**

Rene Tiongquico shared the following updates for ICC:

- The ICC had its first meeting on March 16, 2021. They discussed establishing regularly scheduled meetings, ICC news reporting on <a href="https://www.lmprovelRS.org">www.lmprovelRS.org</a>, and discussions with new and old TAP members on conducting Outreach
- Tiongquico added he shared an update on their work on Social Media during their meeting
- Updating the webpage to align with Social Media guidelines
- March 24, 2021, Tiongquico shared updates from TFPL on responses received from IRS; Subcommittee 1 Go Back Option, Subcommittee 2 the IRS Phone Line and 1040 Instructions providing the telephone option. He shared information on organizational activities, and W&I briefings received.
- ICC will share additional updates during their report.

Tiongquico assured Price he would follow up on the missing information for what Committees were doing on Outreach in the Newsletter and share with the Full Committee. Jimerson added Articles are due by the 25th of the month. Members were encouraged to report their Outreach numbers and submit a brief update to Tiongquico to add to the Newsletter.

- Closing Issues from the Screening Report: #43840, #43844, #44413, #44527 and #44402. She will contact the taxpayers as appropriate
- Forward Issue #44516 to LITC for the information requested and associate with Issue #47303

#### Roundtable

- Price stated her pleasant surprise to discover that The Taxpayer Bill of Rights (TBOR) is provided with a CP295A Notice. She requested that feedback is given to W&I that it is a great way to notify taxpayers that the TBOR exists.
- Rice stated members put in a lot of work, especially on referrals sent in, and would like to see more consideration from the taxpayers' viewpoint. Terrie English will discuss with Rice offline. Rice stated that TAP members work hard on referrals submitted to the IRS on behalf of taxpayers and would like to see referrals taken more seriously. Terrie English asked Rice to follow up with her to discuss.

Jimerson thanked the members for their efforts and reiterated that they are valued and appreciated. The TAP Staff advocates for each TAP member.
