# **National Office Report**

Terrie English thanked everyone for being on the call. She shared the following information:

- The Military Focus group will meet on July 15, 2021 at 12:00 PM, EDT.
   Members were encouraged to attend and share any insight they may have on military personnel interacting with the Internal Revenue Service (IRS)
- TAP has been asked to conduct a Homeless Focus group that will meet in August. The exact date and time will be decided and shared with members
- The Tax Forum registration begins this afternoon beginning at 2:00 PM, EDT. The Forums will begin on July 19, 2021. Members were encouraged to visit the <a href="www.IRS.gov">www.IRS.gov</a> website. There will be thirty live streamed webinars available for credits and members may take advantage of that opportunity. The calendar invite was sent for registration. English will be attending the call today
