This referral highlights seven important areas:

Under "Important Things You Should Know," bold Do not file this form with your tax return, add, which includes an example of a completed Form 8857, and a notice not to complete for injured spouse relief. Confirmation of what address the taxpayer wants to



use, adding in any refunds; add spacing between two paragraphs; add a web address to the Schedule LEP, and enlarge caution bubble. Weigel motioned; Daley seconded. **Action:** Issue elevated to JC after Quality Review (QR)

#### **Issue 50226** - Form 944

The committee is reviewing the effectiveness of this form. We have questions for the program owner, so we are requesting an extension for this review.

## **Issue 49613** (update) - Social Security Benefits Worksheet

We are asking for additional research because the calculations are so complicated with this form.

## Issue 48321 (update) - Section 218 Agreement SSA

We are asking how coordination with other government agencies is done to help clarify this issue. We need a Subject Matter Expert for this project.
