Chair Report Out

IRS Responses:

• **Issue 43054-** IRS Accounts Made Dysfunctional for Non-Resident Americans- Still under consideration

Lammers indicated this issue may have been improved starting in November or December of last year where some international taxpayers are able to set up an account. Some taxpayers are still having issues because of the requirements to set these accounts up. We need to review this issue to see if it is still an issue or if it needs to be rethought. Mills motioned to accept response; Fox seconded.

Action: Response accepted

Issue 43808-Facilitating Payments to IRS by Overseas Taxpayers
The issue remains "Under Consideration by the IRS"



The committee discussed options for taxpayers overseas such as opening US bank accounts to resolve this issue. Opening up US accounts overseas pose a lot of barriers, per Lammers. This issue will be set aside until next month allowing for research. Subcommittee 1 will take this issue.

Issue 43867-Impossible to Get an ITIN

Mills motioned to accept; Patterson seconded. Michael Avery opposed accepting this response because taxpayers are still dealing with this problem.

Action: Response accepted

This issue will be reviewed to see if there is a new issue that can be developed by the committee. Subcommittee 2 will do this research. Jeans stated for the record, majority consensus rules, and if there are any minority objections, the Chair has the authority to send down to subcommittee for them to consider a new project only.

Subcommittee 1: Fox Reported out

 Project Referral Issue 51241-Form 1040SS-US Self-Employment Tax Return

This issue is still being researched.

Subcommittee 2: Patterson Reported Out

Project Referral Issue 51693—Estimated Tax Payments

Patterson explained this issue seeks to review the issues proposed so that taxpayers can make these estimates for their own social security numbers to simplify this being reconciled easier.

Screening Report Out:

They screened 23 of 97 issues. There was an issue from the Parking Lot concerning availability of forms and publications that is still being researched. 49616 Tax Practitioner Contact Information Spoken Publicly. One issue is what information should a taxpayer have to divulge social security number in public. The other issue is coming up with a new error code pertaining to the Form 1095-A. Issue 51445 Living Abroad is Unfair which has to do with foreign bank accounts. The final issue is Form 843 Claims for Refunds. These five remain in the Parking Lot for further research.



There were several issues that we did not take on for various reasons such as legislative and other issues that TAP cannot address. There is an issue we will refer to the Taxpayer Experience office. There is a connected to Issue 51760 concerning Online Payment Centers.
