## **Chair Report**

Nina Tross welcomed everyone to the meeting and provided the following information for the Chair Report:

- Tross participated in the Joint Committee's Planning Session on Tuesday and Wednesday of this week along with TAP Staff; Sheila Andrews, Terrie English, National Taxpayer Advocate, Erin Collins joined the first day for discussions. Maryclaire Ramsey, Susan Jimerson and Cedric Jeans were in attendance as well.
- Appreciation to all members on their attendance and the jobs well done
- Thank you expressed to Sarah Holtzclaw for submitting the article for the Newsletter
- Matthew O'Sullivan will be sharing a copy of the ICC template with members after today's call. Member participation was encouraged to submit articles for the Newsletter
- Reminder expressed to members on how important the Annual Report is.
   The National Taxpayer Advocate, Erin Collins shares the report with Congress and the Commissioner. It keeps them aware of what has been done over the past eight months. The Joint Committee is looking for members to assist with the Annual Report. - Members were encouraged to sign up and work with the Ad Hoc Team on the most serious problems

- The LTA from Hawaii attended the Joint Committee Planning Session using Zoom. She informed members their LTAs are required to reach out to TAP and work with members. If members have not been able to contact their LTA please contact O'Sullivan to assist
- Cindy Jones shared information with the committee on W&I and how they
  have huge responsibilities during Tax season, timelines on when things
  happen, responses that have come through the <a href="www.IRS.gov">www.IRS.gov</a> website and
  viewed the Voice box how they are there to help. They discussed
  humanizing that was interesting on how the public view IRS and having a
  connection with a human. More information may come on this. The Joint
  Committee shared some brainstorming ideas on issues TAP should
  address next year

#### **Program Owner's Report**

Michael Odom shared the following Program Owner's report:

- W&I currently there are no open recommendations or referrals
- There is one reconsideration Issue 41122, Accessibility to TACs due December 01, 2022
- There were no implementation checks
- Two questions were submitted:
  - One question asks whether TAC offices are open or closed. It is due and waiting for the response.
  - Returns affected by Oil and Gas Depletion Deductions. Odom is waiting on research for a response. The research is continuing to work on this. He is working to get an answer on this question for the committee
- The last set of questions are on TAC signage, security, and walk-ins: there
  were a set of four questions on this and Odom is working to get answers
  for these questions by next week



## **Subcommittee Report**

Subcommittee 1

Philip George shared the following updates for Subcommittee 1:

- Both subcommittees met on August 04, 2022
- They discussed the Oil and Gas Royalty training issue. Odom's responded during this meeting. The subcommittee will discuss at next month's meeting
- Issue 54682, Prohibited Items the draft referral was sent by O'Sullivan to both subcommittees. More discussion will be held
- Issue 55247, No Tax Help Available the Taxpayer had no IRS TAC office available within one hundred miles. Research proved there were sites opened. Subcommittee 1 recommended the issue be dropped Phillip George motioned Issue 55247 be dropped and Daniel Leatham seconded

Decision: Full Committee Consensus approved Subcommittee 1 recommendation to drop Issue 55247

#### Subcommittee 2

Paula King shared the following updates:

- Both subcommittees completed the referral for Issue 54682, Prohibited Items. Subcommittee 1 still has to review for possible changes. It will be coordinated between the two subcommittees, presented to the full committee, once approved forwarded to SA and Attorney Advisor to elevate to the Joint Committee
- O'Sullivan added a discussion was held on last week and it was
  determined it is against IRS policy to have security guards making
  determinations. Management advised to reach out to management in the
  TAC offices and inform them of the complaint issues. Jimerson added that
  it is not IRS policy. The security guards are there to screen for security.
  The IRS staff determines if an appointment is needed or resolved the
  same day. When individual issues occur, they are forwarded to W&I to
  address. Subcommittee 2 recommended Issue 55657 to be closed.
  King made the motion to close Issue 55657 and Sarah Holtzclaw
  seconded

  day. TAP will work directly with them at a table in an IRS facility
  nationwide. This will be an opportunity for TAP to work directly with them.
  They will see how TAP does it and TAP will see how they do it. The
  opportunity to get systemic issues to address is the idea. Lillie will be
  reaching out to Simineo.
- The other topic discussed is close the deal. Get to the systemic issue TAP will be able to address. Members were encouraged to close the deal. Look beyond the individual issue to see if there are issues beyond that for TAP to work. The member focus is making referrals up to IRS. Members were encouraged to try and finish the year strong
