- Overview of what TAP committees' procedures shared for public knowledge: subcommittees work the issues, they talk it out, they clean up the document with recommendations, then they forward to the Full Committee for review. The Full Committee makes the motion forward to the Joint Committee to adopt or send back for edits then send back to them before sending to IRS. There are different types of issues whether they affect individuals, businesses, programs from IRS that are not working for people. Part of this is the Outreach and the Screening Committee. Outreach go out and talk with people, listen to what they say and focus on the problem. During the subcommittee meetings, members discuss and talk things through and push things out. The Full Committee meetings is where members pull together.
