Subcommittee -1 report out (Lammers):

Issue 65214 reviewed and decided to drop. Issue 71913 – further research will be done to ensure that the referral is done correctly before submitting to the IRS. Issue 68581 – will schedule a follow up meeting with a SME for clarification and prepare a new referral. Issue 48551- from year 2021 and still waiting for a response from the IRS. Issue 71912- changing the title of the project to "for filing season 2025" instead of "by 2025". Additional edits made to the recommendations. - 2024 ICC will be working on a project regarding a public email list to distribute a listing of the 6-project committee's monthly full committee meetings dates and times for any members of the public that subscribe.
- 2023 Project to add the Speak Up brochure (PUB 3753) and information to VITA/TCE locations order form was successful.
- SPEC agreed to add the link to Speak Up Brochure (PUB 3753) to their publication 5683 for 2025 filing season. Publication 5683 is the VITA/TCE Handbook for Partners and Site Coordinators. Other IRS forms and publications are currently listed within the Publication. The Speak Up Brochure link will be added by the 2025 filing season.
