Bell reported:

Three issues were approved by the JC and sent to the IRS:

- Issue 63737-Data on Wage and Income Transcripts
- Issue 75256-Login.gov Should be Replaced By ID.me
- Issue 67239-Electroni Power of Attorney for Overseas Taxpayers

JC Face to Face Planning Meeting voting for the Chair and Vice-Chair and whether it should be majority or plurality of votes. The decision was made for it to be a majority vote only. The survey results need to have more participation than 20 or 30 members. The was a discussion on allowing members to serve back-to-back tenures instead of the three-year moratorium.

Bell continued that a discuss was held regarding Subject Matter Experts (SMEs) and why we were asking for them. Before a referral is sent up, we need to verify that is still an issue. There is an effort to limit the amount of tax professionals, but we pushed back that we need to keep some tax professionals on the panel. Issue 74358- Credit Transfer Tool

IRS is aware of this issue and working hard to fix it.

Issue 66339- Going to Appeals

We are asking for more information since most taxpayers that go through the appeals process loses. We are still receiving more of the percentages and still issue is still being researched.
