Committee Updates

Response received

Project 72106- Asynchronous communication: Evaluating a centralized communication experience

Almeida indicated that this issue is being considered for a rebuttal and a Subject Matter Expert (SME) has been requested. We are looking for more information to determine why all suggestions were denied.

Issue 72107 (*Taxpayer-requested data: Why they need it and how we can help them achieve their goals*). We are looking for more information from IRS concerning the reasons for the denial of the recommendations

Issue 77909 (*Taxpayer understanding of Form 8821 Tax Information Authorization*) The committee voted to combine this with the referral from Tax Forms and Pubs concerning this issue (77867)

Subcommittee 1 Updates

Tasha Preisner reported:

- Issue 77882 (*Communicating with the IRS: Taxpayer and Tax Professional Perspective*)

This was going to be combined with an issue from Tax Forms and Pubs. However, they decided to forward with their issue alone. We need to decide what we want to do with this issue. This issue will be closed and associated with the issue from Forms and Pubs.

- Issue 77695 (*Keep taxpayers informed*)

We are looking to add more self-service and automation for taxpayers by attaching an “Upload Document” tool to online account and add meaningful status updates. The committee is awaiting additional information from the SME to make a determination.

- Issue 65342 (*IRS have a DLN number*). Awaiting more information from the SME.
- Issue 68815 (*Is there a way to digitally make multiple years of tax returns*) Committee voted to close this issue.
- Issue 70987 Streamlining the Tax Preparation Process. Hwang recommended the issue be kept and offered to write up the recommendations. This will be kept and worked in Sub Committee 2.
- Issue 72107 (*Taxpayer-requested data: Why they need it and how we can help them achieve their goals*). Reviewing IRS Response. Recommending a rebuttal of the IRS determination. This will be discussed with an SME.

Subcommittee 2 Updates

Jose Cintron reported:

- Issue 67401 (*Resubmit a direct deposit refund*)

Will keep for additional research.

Issue 69847 (*Copy of IA letter and terms*) Will keep for additional research.

- Issue 71020 (*When paying taxes online*) Will keep for additional research
- Issue 71114 (*Option to print online Form 14039*) To be closed
